Important Notes

Metis Global (Singapore) Pte. Limited ("Metis SG") is required to collect certain information about your tax residency in order to comply with the Singapore Income Tax Act (Chapter 134) and related regulations including Income Tax (International Tax Compliance Agreements) (United States of America) Regulations 2015 (FATCA) and Income Tax (International Tax Compliance Agreements) (Common Reporting Standard) Regulations 2016 (CRS). If you are tax resident outside the country/jurisdiction where your account is held, we may need to give the national tax authority this information, along with information relating to your accounts. That may then be shared between different country/jurisdictions' tax authorities.

Please note that providing false or misleading information is an offence under the Singapore Income Tax Act (Chapter 134)
